I am a medical graduate from Christian Medical College (CMC), Vellore, one of the premier medical institutions in India. I am a paediatrician, having completed the first half of my paediatric training (DCH) at CMC, Vellore. I secured a place for my Masters (MD) in the highly competitive All India postgraduate selections at Madurai Medical College also affiliated to Dr. M.G.R. Medical University, Chennai. I completed my MD Paediatrics in 1991. I have cleared the MRCP examinations of the UK, and have an MRCP, followed in 2005 by the award of Fellow of the Royal College of Paediatrics and Child Health.

Since 1997 I have been on the faculty of Christian Medical College, Vellore with a dual appointment in Paediatrics and in Community Health. CMC Vellore is a tertiary level referral teaching hospital, which also serves the local population. I am an academic general paediatrician with a focus on Infectious diseases, having 2 years of secondment at the St Bartholomews and the London NHS Trust in the Infectious Diseases Unit. I became a Professor of Paediatrics in 2005.

The department of Community Health runs a 120 bed secondary level hospital with 19 paediatric and 12 neonatal beds, and I am the paediatrician in charge. My research has focused on areas responsible for high child mortality. These are injury prevention, malnutrition, vaccine preventable diseases and perinatal problems.

The job that I have, with dual appointments in two departments has necessitated a degree of planning and networking in order to optimally utilize the strength of both departments. I have led teams that have conducted large research projects, e.g., the preparatory phase for the *Haemophilus Influenzae B* (HIB) vaccine trial to establish the burden of disease due to pneumonia and meningitis in India. During the course of these projects I have had extensive collaborative relationships with universities, research NGOs, health care service providers, and industry and government departments. I have also had experience in dealing with the regulatory agencies in India such as the Drug Controller General of India (DCGI), the Indian Council of Medical Research (ICMR), and the Department of Biotechnology (DBT).

I am an alumnus of the Advanced Vaccinology Course that is held annually at Annecy in France (ADVAC 2001). I have successfully secured funding for, organized and conducted the first Advanced Vaccinology Course in India (INDVAC). The INDVAC is now in the fourth year of being organized. I have been the Principal investigator on the following vaccine trials: Boostrix, GSK Rota Vaccine, Rabies vaccine trial. And co-investigator on the 116E Rotavirus vaccine efficacy trial.
